## Setanta Risk Assessment

Last reviewed July 2021. Review required July 2022 unless stated otherwise against individual risks.

It is the responsibility of the skipper to maintain a dynamic risk assessment and to always operate within the limits of their own knowledge, skill and experience, the ability of the participants, and the prevailing conditions.

Covid-19	Severe illness or death	All participants	Group Leader to confirm that all participants have not shown any symptoms of Covid for at least 14 days prior to event.  Leader in charge to have a complete list of participants names and contact details to comply with any track and trace requirements.  Number in Group: Skipper to assess and confirm the total number of participants onboard based on weather conditions and maintaining social distancing. With guidance around general social distancing at 2m the expected total number onboard is likely to be 4 but this may be adjusted due to allocated tasks (bow/foredeck use) and physical size of individuals. Skipper to brief participants of the restricted space onboard and explain the limited use of the Cabin area (1 person only).  Maintain social distancing where possible. Participants to wear face masks/coverings when working less than 2m apart.  Cabin area to be accessed by one person at a time. This would be to adjust lifejacket/personal floatation device, change clothing (add warmer layers or remove excess layers), or to pass bags up for breaks.  Only in a First Aid situation should more than one person be in the Cabin area.  All surfaces in the Cabin should be wiped down after access using appropriate wipes. When changing helm consider wiping down surfaces to reduce possible cross infection. Pre-activity brief to include each participant carrying and using their personal hand sanitiser. Before and after using any ropes and equipment use hand sanitiser or gloves may be worn. If anyone in the group develops symptoms, cough or temperature then the session should be abandoned.  The appropriate isolation of lifejackets/personal floatation devices is to be followed (current advice 48 hrs between uses).
